# 2. Finance and Audit Committee meeting 5/8/15

Report previously circulated of meeting minutes and subsequent work undertaken. Special thanks to Linda Tyrrell were expressed by the Board for all of her work on this matter.

Next steps agreed:

- A formal written agreement between HGI, HGC & HGP regarding the sharing of costs and accommodation to be agreed and on file for the PSA to review:

- A formal written agreement between HGI, HGC & HGP regarding the ownership of data should be put in place defining; who owns what, who accesses what, levels of confidentiality, etc., for the PSA to review Action: Celia to progress with Chalvington team
- A Risk Management Policy should be prepared, agreed and on file for the PSA to review

• Membership fee levels to be set slightly higher than previously agreed:

#### **Graduate members**

Current - £90 (UK) and £98 (Overseas)

Increase - £120 (UK) and £128 (Overseas)

#### **Members and Fellows**

Current - £90 (UK) and £98 (Overseas)

Increase - £150 (UK) and £158 (Overseas)

Agreed that the increase to take effect from 1st November 2015

 The wording for Standard 4 of the PSA Application needs to reflect the increased fee structure (if approved) to members and a full explanation of income and expenditure of the Institute drafted.

It was observed that financial sustainability is important as a requirement for the PSA application in order to ensure the long term viability of the HGI. Currently the biannual conference is the main income generator beyond membership fees. **Ivan proposed holding the conference annually.**
